## JOURNEYMAN TEAM EVENTS

#### Journeyman Master Judge

Aaron Haderle Kissimmee Utility Authority, Florida

#### 4kV Alley Arm Insulator Change Out

**Chief Judge: Gaspareni Dixon,** Memphis Light Gas and Water, Tennessee

This event is simulated energized at 4kV on 1/0 ACSR three-phase straight line circuit with a single 8' wooden cross-arm, braced with a 7' alley-arm. The team will change out the center phase pin insulator.

#### 12kV Arrestor Change Out

Chief Judge: Cody Raveling, Minnesota Municipal Utilities Association, Minnesota

The team will change both cross-arm mounted lightning arrestors on an energized 12kV two-phase tangent line.

#### Hurtman Rescue

**Chief Judge: Matt Hyatt,** Huntsville Utilities, Alabama

This team event will run once, with all team members rescuing the hurtman—one must climb, one must open switch, and one must tag the manneguin. The mannequin will be lowered to the ground while the third team member ties the bottom part of the handline to the mannequin's legs to pull it onto the tarp. Teams must keep the manneguin off the pole and hardware. There will be NO gigs for incidental contact of the mannequin on the pole or neutral conductor provided the tagman is making an honest attempt. The mannequin's whole body must land gently (as if it were human) on the provided tarp provided

#### 12kV Pole Transfer

Chief Judge: Scott Windham, Santee Cooper, South Carolina

Teams will be required to transfer the 1/0 ACSR primary conductor and neutral to a new pole. Poles will be set 4' apart and will be pre-drilled with the appropriate holes for material installation. The primary conductor will be on a pole top pin and insulator and the neutral on a spool bolt. Both conductors will be tied in with #6AL solid tie wire. The primary conductor will be tied with a "Hot" tie and the neutral will be hand tied on the spool.

#### **URD Install**

*Chief Judge: Todd Prangley,* Sacramento Municipal Utility District, California

This event will consist of a singlephase riser made up complete with the hot line clamp not attached and the cutout open. This is going to a new 25kvs mini pad transformer that is partially made up except the elbow and the secondary connections. The elbow will need to be installed on the primary and secondary conductors placed onto the mini pad transformer. The secondary connector must be stripped and landed in the secondary bars. The meter that this transformer is feeding is a simulation and is pulled already. The hot line clamp will need to be installed onto the stirrup which will be attached to the primary and cutout closed and the voltage checked at the transformer. After the voltage is checked the time is stopped. After the time is stopped the team must open the cutout, take the hot line clamp off, cut the elbow off, remove the secondary's, and put the event back like it was before starting.

#### **Apprentice Master Judge**

Kenneth Roberts ElectriCities of North Carolina, North Carolina

#### **3-Phase Fuse Replacement**

**Chief Judge: Darin Koehler,** San Marcos Electric Utility, Texas

This event will be simulated dead. Rubber gloves are NOT required; however, the apprentice shall perform the task by complying with all safe work practices. Time will start at the judge's signal. The apprentice must change the fuse links from all three cut-out switches and close the switches simulating restoring power.

#### Hurtman Rescue

#### Chief Judge: Dave Dwinell,

Denton Municipal Electric, Texas

This event is a simulation of rescuing an injured co-worker. The apprentice must ascend the pole and safely lower the mannequin to the ground. Time starts at the judge's signal with the apprentice standing at least an arm's length from the pole in any direction. Note: The apprentice's belt, hooks, and rubber gloves in bag will be lying on the ground at arm's length.

#### Load Transfer

*Chief Judge: Woodie Wilson,* ElectriCities of North Carolina, North Carolina

This event will consist of moving the transformer jumper from one outside phase to the other outside phase. The load must be removed from the 240/120volt conventional transformer by opening the load-break fused cutout with an extendo stick. Once the fuse is open, the competitor must ascend the pole and transfer the high-side jumper from one outside phase to the other outside phase. The competitor must then descend the pole and reenergize the transformer with the extendo stick.

#### **Service Connection**

Chief Judge: Fredrick Rumery, Lincoln Electric System, Nebraska

In this event, the apprentice must hang a #2 triplex service between weatherhead and pole. The service conductor will be pre-cut and two-loop coiled, lying flat on the ground at the weatherhead at the start of the event. The competitor will make up the weather head, rig a length of 3/8" three strand rope to the line-end of the triplex, don climbing tools, ascend the pole, sag the triplex, and make the buss connections. The pole will be clearly marked around its girth 6' below the secondary buss with a 3" diameter band of yellow paint. Time stops when the climber's safety strap crosses the mark.

On the judge's signal, un-timed, the competitor will ascend back up to the triplex and disconnect and drop the triplex with the service wedge clamp attached to the ground. The competitor will properly warn the judges before releasing the service. The competitor will remove the connectors and bring them down the pole in the competitors dity bag. After descending the pole the competitor will remove climbers and install gaff guards. Scoring of the competitor ends when climbers are removed and gaffs properly covered.

#### Written Test

Chief Judges: Shane Scott, Huntsville Utilities, Alabama, and Jeremy Ash, Kansas City Board of Public Utilities, Kansas

This 20-minute written test, based on the Association's Safety Manual for an Electric Utility, 16th edition, to determine the apprentice's knowledge of safe work practices. The test takes place on Friday afternoon at the Broadmoor. The safety manual is available at www.PublicPower.org>Shop.
