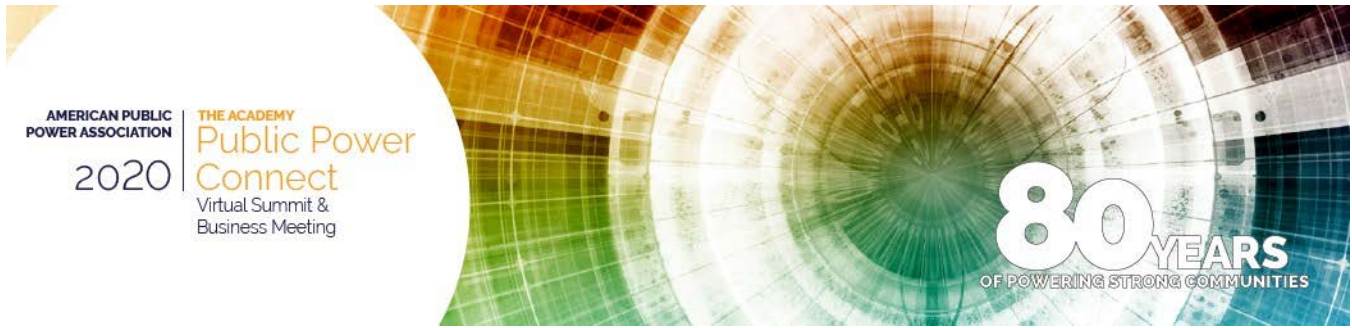

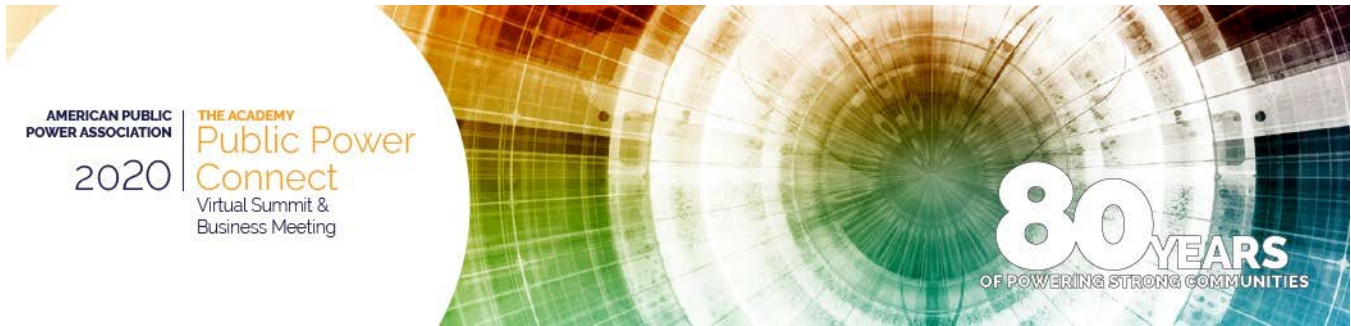

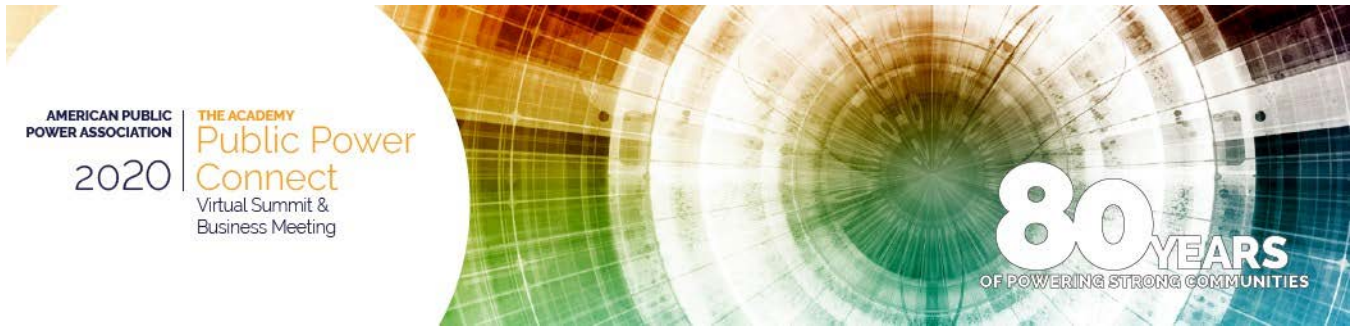
1. Congressional Action to Address the COVID-19 Pandemic
