It appears unlikely that the White House, Republicans, and Democrats will reach an agreement on COVID-19 relief legislation prior to the election. However, APPA continues to advocate for public power's priorities in a future COVID-19 relief bill, with our top priority being the inclusion of a forgivable loan program for public power utilities impacted by customer nonpayments due to the pandemic. We strongly encourage all APPA members to contact their Senators and Representatives to express support for including this language in the COVID relief package should negotiations resume.

The public power <u>Mutual Aid Working Group</u> swung into action again to support those most affected by Hurricane Sally that impacted Alabama and a portion of the Florida panhandle. Check out APPA's <u>talking points</u> on hurricane preparedness and mutual aid during a pandemic.

APPA announced a <u>new partnership with the</u> <u>U.S. Department of Energy's National</u> <u>Community Solar Partnership</u> (NCSP) to expand access to technical assistance for public power utilities working on providing community solar.
