Who is eligible for government associate membership?

State or local government agencies, including cities, towns, counties, and other public agencies in the U.S., its territories and possessions that may be interested in learning more about public power and the options they have with regard to their community's electricity service are eligible for membership in this category.

State or local government agencies that offer other utility-type services (gas, water, wastewater, telecom, cable TV/satellite TV), as well as State or local government agencies with public power oversight or regulatory responsibilities can join to take advantage of Association resources.
