## Who is eligible for private energy associate membership?

Power marketers (organizations that take title to power and have contractual obligations to deliver it), power brokers (organizations that arrange power sales or purchases without taking title to the power), and independent power producers (organizations that own power plants and sell electricity generated by those plants on the U.S national power grid on a for-profit basis) of electric, gas, or other utility services are also eligible for membership in this category.
